
"Fake News and Ethics in Journalism"

We've all heard the attacks on the media and the charge of fake news and alternative facts. What does it mean? How can we assess the accuracy of information especially in this era of electronic and fast moving information? While, the media has been called the

"fourth estate" of American government and plays an essential role in our democracy along with the judiciary, executive and legislative branches, the media has been under serious attack.

Come hear ASU Senior Research Professor **Douglas A. Anderson** address the issues surrounding media, fake news and the role of the media in our democracy. Having served from 1987-1999 as ASU Director of the Cronkite School, Anderson rejoined the Cronkite School in 2014 as a senior research professor after retiring from Penn State University's College of Communications. He had served at Penn State from 1999 to 2014 as dean and professor of journalism. He is also a past president of the Association of Schools of Journalism and Mass Communication and in 2013, he received the Presidential Award from the Association for Education in Journalism and Mass Communication.

AAUW Arizona - NWV Branch Resolution on Sexual Harassment and Assault

- WHEREAS all people need a safe, professional, supportive environment where they can grow and work optimally,
- WHEREAS disturbing allegations of sexual assault and harassment by powerful, high profile men have prompted increasing numbers of women to come forward with stories of how predatory sexual behaviors have impacted their lives and careers,
- WHEREAS acts of predatory sexual behaviors may know no gender, women and girls have been disproportionately impacted,
- WHEREAS the problems of sexual harassment and assault impact people in homes, business, entertainment and media industries, sports, education, health care and scientific entities, the accommodation, food and retail industries, at all levels of government, and are known to be systemic and culturally pervasive.
- WHEREAS, though more visible in high profile cases, low wage workers are particularly vulnerable to predatory sexual behaviors and the incidence is more prevalent in industries which rely on customer service and where employees are expected to please and/or to endure harassment.
- WHEREAS sexual harassment is a form of sex discrimination that violates Title V11 of the Civil Rights Act of 1964,
- WHEREAS, equality of rights under the law should not be denied or abridged by the United States or by any state on account of sex,
- WHEREAS sexual harassment intimidates, disempowers and discourages women in many occupations,
- WHEREAS, our culture has tended to ignore, minimize, silence, blame the victim and/ or coverup instances of sexual harassment and assault, victims have been reluctant to speak out, fearing repercussions to their life, job, or career,
- WHEREAS the vision of AAUW is to empower all women and girls to reach their highest potential and the mission is to advance equity for women and girls through advocacy, education, philanthropy and research,

THEREFORE, be it resolved that AAUW Arizona shall increase efforts to empower all people to reject, report and expose predatory sexual behaviors,

The increased efforts of AAUW Arizona shall include:

- (1) branch meeting programs and through leadership and/or support offering programs in communities, colleges and schools,
- (2) speaking out via publication of our positions in the media,
- (3) advocating for strong human resource responses and a climate where the victims of predatory sexual behaviors are neither blamed, retaliated against, or held to pay-off and non-disclosure clauses that are used to cover-up the predatory behaviors
- (4) asking our elected officials and candidates for elected office to sign a pledge to do all that they can to end sexual assault and harassment, and
- (5) asking our elected officials and candidates for elected office to sign a pledge to vote for the Equal Rights Amendment when it is introduced into the Arizona Legislature.

AAUW- NWV Branch Supports Efforts to Increase Arizona Teacher's Pay.



Our NW Valley Branch of AAUW sent out 157 ballots to the membership to propose public policy initiatives for our branch. We received 108 ballots back. The ballots were tabulated by two visitors from Florida and showed overwhelming agreement on item #2: "I want our branch to support legislative efforts to increase AZ teachers' pay" with 101 votes agreeing, 1 no opinion, and 4 disagreeing. The population of Arizona teachers is overwhelmingly female with elementary teacher population estimated to be 85 percent female.

Craig Harris of the <u>AZ_Republic</u> reported Dec. 20th, 2017 that "AZ elementary-school teachers are the lowest paid in the country while high-school teachers rank No. 48 in pay." WalletHub rated AZ as the worst place to teach, and the Morrison Institute released a study which showed that 42 percent of AZ teachers hired in 2013 quit by 2016. The AZ School Personnel Administrators Association report states that 526 teachers had quit as of Oct 1st, 2017 and found AZ is short 1,398 teachers this school year.

Teachers, parents and public school advocates plan to rally at the state Capitol on Jan. 6th to call on the Legislature to significantly raise teacher pay during a Save Our Schools Arizona event. A CEO Advisory Group to Gov. Ducey is supporting increased teachers' pay through a sale's tax initiative. The group has drafted a referendum to be offered at the 2020 ballot, according to Jim Swanson, co-chair of the Governor's Classrooms First Initiative Council.

A general mission statement "to support teachers" scored 95 votes in agreement, six no opinion, and four against, so we will offer ideas and projects for those who want to follow through on that initiative. Regarding involvement in efforts to repeal SB 1431 (which allows state public school funds to go to the cost of private school tuition) 80 votes were in support of repeal efforts, several had no opinion and 17 were against efforts to repeal SB 1431, and NW AAUW public policy committee will not engage this issue.

Ten of us from the branch have signed up for public policy committee work, and each will be contacted by phone and e-mail for the January kick-off meeting.

How do we find and keep certified teachers? What issues must be addressed in school funding? Attend the Public Education Forum/Get the Facts!

Public schools have always been the great promise of a free society and teachers are the key and irreplaceable element in a good public education system. Findings from the Arizona State University Morrison Institute (MI) for Public Policy show "teacher recruitment, retention and pay at crisis levels in Arizona with more teachers leaving the profession annually than bachelor of education degrees produced by the three universities, compounded by an exodus of instructors for reasons ranging from retirement to poor salaries." In a country where salary equates with status, teachers have slipped from being able to make a living to relying on second jobs to get by. As noted in an Arizona Republic editorial, "Arizona needs to look hard at the twin realities of what teachers face and how our schools are performing."

Our students receive 31 percent less in per-pupil funding than the national average, even though we have some of the highest rates of childhood poverty in the nation. At the same time Arizona is facing a teacher shortage and billion dollar school funding deficit, lawmakers have continued the trend of cutting taxes and/or increasing tax credits every year but one since 1990. The result: a cost to the general fund of more than \$2.2 billion in revenues and more than double that amount when adjusted for inflation.

<u>Attend the West Valley Public Education Forum on Thursday, Jan. 25th</u> and hear **Dan Hunting**, Senior Policy Analyst and principal researcher, discuss findings from the 2017 MI released study, <u>Finding and Keeping Teachers</u>. Hear **Dana Naimark**, President/CEO of the Children's Action Alliance addressing funding issues. Listen to **Jennifer Johnson** address impact for all. Take part, ask questions and get documented and factual information.


AAUW Arizona 2018 Legislature Day Feb. 20, 2018

Pamela Powers Hannley will be our featured speaker on the introduction of the Equal Rights Amendment to the U.S. Constitution for passage by the Arizona Legislature.

This amendment has been on hold for almost 30 years. Rep. Powers is leading an effort in Arizona to secure passage in Arizona this year. That will put the amendment one state vote away from passage. We urge you to put this date on your calendar and plan to attend.

Our own state elections in 2018 will make this an excellent opportunity to see which of our elected officials support women's rights and the ERA.

Procedures for Community Action Project Applications due March 15

The State Board of Directors has approved \$2,000 for qualifying community action projects. Branches may submit as many as two separate proposals if they implement two separate projects and combined, their budgets do not exceed \$500. The total number of funded projects will be determined by the funds available. Winning proposals will be announced in the spring edition of the AZ Sun newsletter.

Proposals must be received by the AAUW-AZ Community Action Grant Chair by **March 15.** Completed proposals may be sent by e-mail or US mail. Alert the CAGC in advance of e-mailing a proposal so that she can anticipate its receipt. Hand-written proposals will not be considered. E-mail proposals must include a scanned copy of the cover page of the application form including the signatures of the branch president and branch community action chair. The CAGC will confirm receipt of proposals by e-mail.

Projects must clearly reflect the AAUW mission. Branches are encouraged to develop projects which actively engage members in their implementation. Activities covered by the grant must be completed and a final report describing the project and use of funds (including receipts and a completed AAUWAZ expense claim form) must be received by the CAGC on or before June 1 of the following year.. Please include the name and address of the branch treasurer.
